**ARTICLES OF ORGANIZATION FOR CREATIVE ANGLE DESIGN, LLC**

**ARTICLE 1 -- Name.** The name of the limited liability company shall be Creative Angle Design, LLC.

**ARTICLE 2 -- Address of Principal Office.** The mailing address and principal office of the limited liability company shall be 1637 Springtime Loop, Winter Park, Florida 32792.

**ARTICLE 3 -- Registered Office and Registered Agent.** The name and the Florida street address of the initial registered agent is Gisele Marasca, 1637 Springtime Loop, Winter Park Florida 32792.

**ARTICLE 4 -- Management.** One or more managers shall manage the limited liability company. Therefore, it is a manager-managed company.
