## ARTICLES OF ORGANIZATION

OF

### CARMEL TOP, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I

##### Name

**ARTICLE VI**

**Admission and Withdrawal of Members**

No additional members shall be admitted to the Company except with the unanimous written consent of the members of the Company.

**ARTICLE VII**

**Termination of Existence**



**ARTICLE VIII**

**Manager**

The managers shall hold the offices and have the responsibilities accorded to them by the members as set out in the Operating Agreement.


Pursuant to the provisions of Florida Statutes, the undersigned Limited Liability Company submits the following statement in designating the registered office/registered agent, in the State of Florida:
