ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, for the purpose of forming a Limited Company under the laws of the State of Florida, sets forth the following:

ARTICLE I

NAME

The name of the Limited Company is OSJ ADVISORS, L.C.

ARTICLE II

PERIOD OF DURATION

The period of duration of the Limited Company shall commence five days prior to the filing of these Articles in the office of the Secretary of State of Florida and shall terminate upon the first to occur of the following:




