**ARTICLES OF ORGANIZATION FOR  
MONEY SOURCE PAWN & FINANCIAL SERVICES, LLC**

**ARTICLE I - NAME**

The Company shall be a manager-managed Company, and the initial Manager is Raymond L. Cheshire.

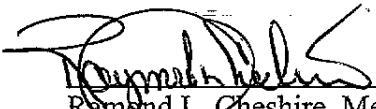
**ARTICLE V - PURPOSE**

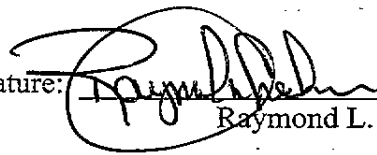
