## **ARTICLES OF ORGANIZATION**

**FOR**

**JABEZ, L.L.C.**

The undersigned, being a duly authorized member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

### **ARTICLE I. NAME**

The name of the limited liability company is **JABEZ, L.L.C.** (the "Company").

### **ARTICLE II. ADDRESS**

The principal office and mailing address of the Company is:

### **ARTICLE III. DURATION AND CONTINUATION**

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement or (ii) by the unanimous written agreement of all Members.

### **ARTICLE IV. PURPOSE**

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

### **ARTICLE V. REGISTERED AGENT AND OFFICE**

The Company designates 1900 W. Commercial Boulevard, Suite 100, Ft. Lauderdale, Florida 33309 as the street address of the initial registered office of the Company and names Anna C. McCoy the Company's initial registered agent at that address to accept service of process within this state.

### **ARTICLE VII. MANAGEMENT**

The business of the Company shall be conducted, carried on, and managed by Managers, who shall be elected annually by the Members of the Company in the manner prescribed by and provided for in the Operating Agreement of the Company. Such Managers shall also have the

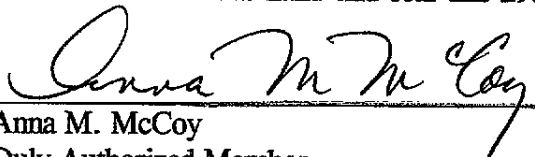

#### **ARTICLE VIII. OPERATING AGREEMENT**

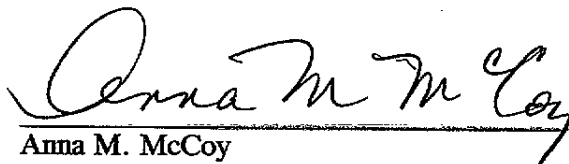
The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company.
