ARTICLES OF ORGANIZATION**OF****Palm Land, LLC**

The name and address of the registered agent of the company in the State of Florida is Lloyd G. Rushing, 119 West Sunset Avenue, Pensacola, FL 32507.

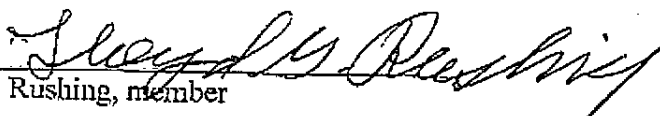

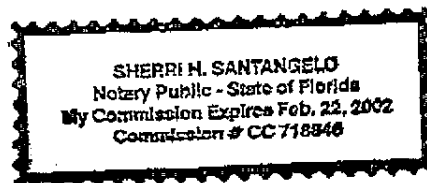

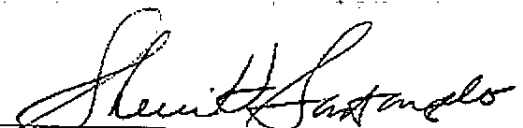
