**ARTICLES OF ORGANIZATION
OF
AVIATION TECHNICAL SERVICES, L.L.C.**

ARTICLE I

NAME

The name of this limited liability company (the "Company") is **Aviation Technical Services, L.L.C.**, and its mailing address is 8440 Tradeport Drive, Suite 109, Orlando, FL 32837, and the principal place of business of the Company shall be located at 8440 Tradeport Drive, Suite 109 Orlando, FL 32837.

ARTICLE II

COMMENCEMENT OF CORPORATE EXISTENCE

This Company shall commence existence on the date of signing these articles of organization and shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III

GENERAL PURPOSE; GENERAL POWERS

The general purpose of this Company shall be the transaction of any and all lawful business. This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law, with such limitations as may be set forth in the Company's Operating Agreement from time to time.

The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager-managed company. The initial manager is John W. Shaffer.

ARTICLE VI
REGULATIONS

The power to adopt, alter, amend or repeal the Regulations of the Company or the Operating Agreement of the Company shall be vested in the Members.

ARTICLE VII
ADMISSION OF NEW MEMBERS

Additional Members may be admitted from time to time on such terms and conditions as are set forth in the Company's Operating Agreement.


