ARTICLES OF ORGANIZATION

OF

BROOK & TIPTON, P.L.

The undersigned, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, and under the Florida Professional Service Corporation Act, Florida Statutes Chapter 621, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

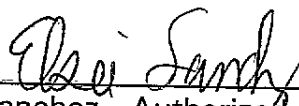

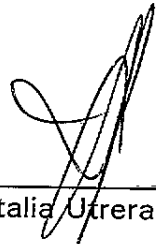
