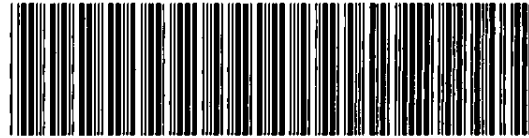

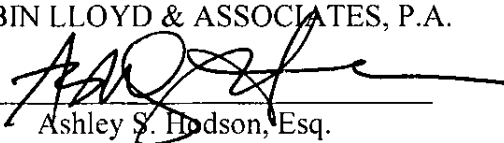

**AMENDED ARTICLES OF ORGANIZATION**

OF

(a Florida Limited Liability Company)

(Right to Continue Business)

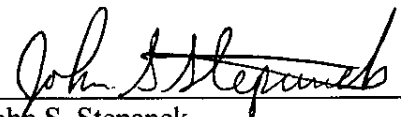

(Management)

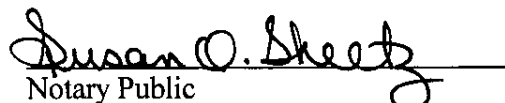
