The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

## ARTICLE VIII -- INITIAL MEMBER


The initial members of the company shall be James H. Rosenberg and James Rosenberg.
