ARTICLES OF ORGANIZATION

FOR

81ST STREET DEVELOPMENT COMPANY, L.L.C.

The undersigned, acting as the organizing Members of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby form a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby set forth the following Articles of Organization (the "Articles"):

ARTICLE I

<u>Name</u>

The Name of the Company is 81st Street Development Company, L.L.C., Florida limited liability company.

ARTICLE II

Commencement Date and Duration

The Company's existence shall commence upon filing these Articles with the Florida Department of State, and shall continue perpetually unless dissolved in accordance with Section 608.441 of the Act.

ARTICLE III

Purpose

The Company is created to engage in any lawful activity.

ARTICLE IV

Principal Office

The mailing address and the street address of the principal office of the Company shall be 525 8th Street West, Bradenton, FL 34205.

ARTICLE V

Registered Agent and Office

The initial registered agent for the Company for service of process shall be Reed W. Mapes, and the address of the registered agent shall be 525 8th Street West, Bradenton, FL 34205.

ARTICLE VI

Management of Business

The Company shall be managed by a Manager or Managers. Mapes & Mapes, Inc., 525 8th Street West, Bradenton, FL 34205, and Jeffrey Ellard Wilson, 1281 Gulf of Mexico Drive, #1006, Longboat Key, FL 34228, will serve as Managers of the Company until their successors are elected and qualified as provided in the Operating Agreement. The Manager is hereby authorized to convey and encumber title to all real and personal property of the Company, borrow money or obtain other financial accommodations for the Company, create security interests in any property of the Company, and to otherwise deal with the assets and property of the Company in any manner which the Manager deems appropriate. In furtherance of such authorization, the Manager shall have the authority to execute on behalf of the Company any and all agreements, deeds, mortgages. security interests, conditional sales contracts, trust agreements, indentures, leases, conveyance documents, and all other certificates, instruments, affidavits, and documents as are necessary, reasonable or desirable to convey or encumber title to any real or personal property of the Company. The signature and execution of such documents by the Manager shall clearly set forth that the execution is on behalf of the Company, and that the Manager is signing on behalf of the Company. Third parties may rely upon the execution of such documents by the Manager as binding on the Company without further inquiry, consent, or approval. Notwithstanding the foregoing, if there is more than one (1) Manager, the foregoing acts shall require the someurence and joinder of all Managers.

ARTICLE VII

Admission of Additional Members

Additional Members may be admitted only by the unanimous vote or consent of the Class A and Class B Members, upon terms and conditions established by the Class A and Class B Members from time to time in their sole discretion.

ARTICLE VIII

Membership Classes

The Company shall have three (3) Classes of Membership designated as "Class A", "Class B", and "Class C". The rights, obligations, and responsibilities associated with each Class of Membership shall be set forth in the Operating Agreement for the Company.

ARTICLE IX

Powers .

The Company shall have all of the powers and authority set forth in Section 608.404 of the Act unless limited by these Articles of Organization or the Operating Agreement.

ARTICLE X

Property

- (a) <u>Ownership</u>. All property originally paid or transferred to the Company as contributions to capital by the Members, or subsequently acquired by purchase or otherwise on account of the Company, shall be the property of the Company.
- (b) <u>Title</u>. The title to all property of the Company shall be held in the name of the Company.

ARTICLE XI

Amendments

These Articles may be amended or restated at any time by the unanimous vote or consent of the Class A and Class B Members, and such amendment or restatement shall be filed with the Florida Department of State in accordance with the provisions of Section 608.411 of the Act

ARTICLE XII

Operating Agreement

An Operating Agreement shall be prepared and adopted to govern the internal actions of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Operating Agreement may conflict with the provisions of these Articles unless permitted herein. The power to adopt, alter, amend, or repeal the Operating Agreement shall be set forth therein.

ARTICLE XIII

Contracting Debts

No debt shall be contracted nor liability incurred by or on behalf of the Company except by its Manager or Managers, and no Member is authorized or empowered to contract debts or incur liabilities on behalf of the Company unless such Member is also a Manager.
