ARTICLES OF ORGANIZATION

OF

HILLSIDE APARTMENTS OF TALLAHASSEE, L.C.

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under Chapter 608, Florida Statutes, the Florida Limited Liability Company Act.

ARTICLE I - NAME

- B. Sonya K. Daws has made a cash contribution of \$95,000.00, and has one(1) vote, constituting a 25% interest in the Company.
- C. Thomas Edwards and Linda Edwards, husband and wife, have made a cash contribution of \$95,000.00, and together, have one (1) vote, constituting a 25% interest in the Company.
- D. Elliott Varnum and Donna Kay Varnum, husband and wife, have made a cash contribution of \$95,000.00, and together, have one (1) vote, constituting a 25% interest in the Company.

In the event additional contributions need to be made to the Company, the members shall contribute their portion prorata. In the event a member is unable to make a contribution, the other members shall make that member's prorata contribution, and the contributing member's ownership percentage shall be increased accordingly.

ARTICLE VI - MANAGEMENT

The Company is to be managed by a board of two (2) managers, the initial membership of which, who shall serve until the first annual meeting of members, are identified as follows:
