**ARTICLES OF AMENDMENT TO ARTICLES OF

In consideration of Ten and No/100 Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency of which is conclusively acknowledged, the parties hereby agree as follows:

1. It is hereby ratified and acknowledged that Thomas Edwards and Linda Edwards, husband and wife, sold, transferred and conveyed their twenty-five percent (25%) interest in the LLC to Arthur P. Wimberley, Jr. and Donna Wimberley, husband and wife and Elliott Varnum and Donna Kay Varnum, husband and wife, who, sold, transferred and conveyed that twenty-five percent (25%) interest to Tommy Watts and Susan Watts, husband and wife.
2. It is hereby ratified and acknowledged that the twenty-five percent (25%) interest of Sonya Daws is held 1/3 by her individually and 2/3 by National Bank of Commerce as Custodian for Sonya K. Daws IRA Rollover Account.
3. As previously voted upon by the members, and as reflected in the annual report of the LLC filed for 2002 with the Florida Department of State, the two managers of the LLC are: Elliott Varnum and Sonya K. Daws.
4. Except as expressly stated herein, all other provisions of the original Articles of Organization of the LLC shall remain in full force and effect.
