Other Provisions

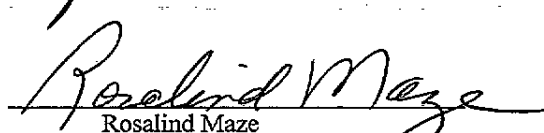
1. The members of the Company may admit additional members with the unanimous approval of all the members.

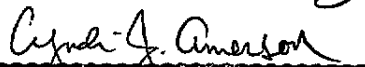
