ARTICLES OF ORGANIZATION OF TERRA-COM PROPERTIES, L.L.C.

1. Name. The name of the limited liability Company (hereinafter referred to as "Company") is: TERRA-COM PROPERTIES, L.L.C.
2. Existence. The Company shall have perpetual existence commencing with the date of filing.

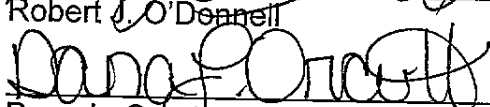
