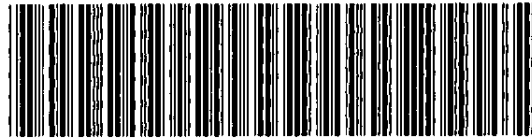

All debts, obligations and liabilities of the limited liability company have been paid or discharged.


All remaining property and assets have been distributed among the members in accordance with each member's respective rights and interest.
