The mailing address and street address of the principal office of the Limited Liability Company is 18401 Murdock Circle, Port Charlotte, Florida 33948.


ARTICLE III — Registered Agent & Registered Office

The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager-managed company.




