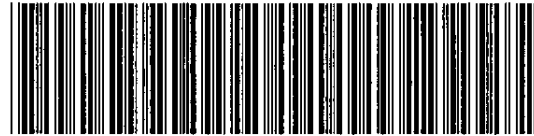

- FIRST:** The name and address of this corporation is **CLICK GRAPHIC STUDIO, LLC.**, 4304 Vineyard Circle, Weston, Florida 33332.
- SECOND:** The date of the adoption of these Articles of Dissolution is 11 August 2009.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
