# AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR COURTYARD AT HOMESTEAD, LLC

These Amended and Restated Articles of Organization for COURTYARD AT HOMESTEAD, LLC are being filed pursuant to Section 608.411 of the Florida Limited Liability Company Act and hereby amend, in their entirety, the Articles of Organization filed for COURTYARD AT HOMESTEAD, LLC on June 18, 2001.

### Article I - Name

The name of the Limited Liability Company is COURTYARD AT HOMESTEAD, LLC (the "Company").

#### Article II - Address
