The undersigned, CRAFTSMAN HOLDING, INC., a Florida corporation and the initial member of CRAFTSMAN CONTRACTORS, L.L.C., hereby presents these Articles of Organization as the Articles of Organization of CRAFTSMAN CONTRACTORS, L.L.C., a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

**ARTICLE I - NAME**

The name of the limited liability company is:

CRAFTSMAN CONTRACTORS, L.L.C.

This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the principal office of the Company is 55 South B Street, Pensacola, Florida 32501.

**ARTICLE III - PURPOSES AND POWERS**

This Company is organized for any legal and lawful purpose for which a limited liability company may be organized and may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act.

**ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE**

The date for commencement of the Company's existence shall be June 14, 2001 if these Articles of Organization are filed with the Secretary of State of Florida on or before June 21, 2001, otherwise the date of commencement of this Company's existence shall be the date these Articles of Organization are filed with the Secretary

of State of Florida. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

#### **ARTICLE V - REGISTERED OFFICE AND AGENT**

The address of the registered office of the Company is 55 South B Street, Pensacola, Florida 32501, and the name of the registered agent at that address is Patrick Sullivan.

#### **ARTICLE VI - MEMBERS**

The Company may have more than one class of members as described in the Operating Agreement. Members shall receive membership unit certificates representing their proportionate ownership of the Company. The rights, privileges and duties of members shall be as described in the Operating Agreement.

#### **ARTICLE VII - MANAGEMENT**

Except as otherwise provided in the Operating Agreement, the Company will be managed by its managers who shall be selected in the manner described in the Operating Agreement. The name and address of the initial manager of the Company are:

#### **ARTICLE VIII - ADMISSION OF ADDITIONAL MEMBERS**

New members may be admitted to the Company only as provided in the Operating Agreement. Contributions required of new members shall be determined as of the time of admission to the Company.

#### **ARTICLE IX - RESTRICTION ON MEMBERSHIP**

A member may not sell or otherwise transfer the member's Membership Units until the member has complied with the restrictions, including a right of first refusal, contained in the Operating Agreement for the Company.

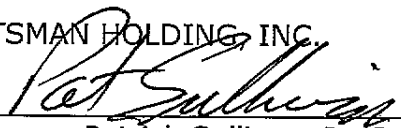
**ARTICLE X - AMENDMENT**
