The Company shall be manager managed in accordance with the terms of the Company's Operating Agreement. The name of the initial manager shall be Ambrosio Castellano.

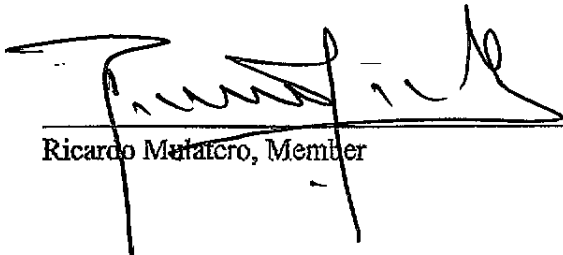
