**ARTICLES OF ORGANIZATION
OF
BEUS, LLC
(A Florida Limited Liability Company)**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be BEUS, LLC (“Company”).

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Company in Florida shall be 801 International Parkway, 5th Floor, Lake Mary, FL 32746.

ARTICLE III – COMMENCEMENT

The Company shall commence on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV – PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE V – REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is David C. Willis, 225 E. Robinson Street, Suite 600, Orlando, FL 32801.

ARTICLE VI – ADMISSION OF NEW MEMBERS

Additional members shall be admitted to the Company upon such terms and conditions as shall be set forth in the Operating Agreement of the Company.

ARTICLE VII – TERMINATION OF EXISTENCE

The Company shall be dissolved upon the bankruptcy or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in the Company as provided in Section 608.441, Florida Statutes, unless the business of the Company

is continued by the consent of all the remaining members, provided there is at least one remaining member.

ARTICLE VIII – MANAGEMENT

The Company shall be managed by one or more managing members in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. This Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 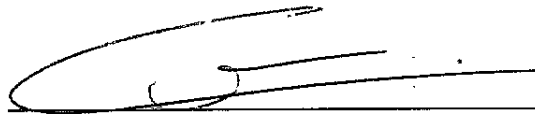
ARTICLE IX – LIABILITY FOR COMPANY DEBTS
