## ARTICLES OF ORGANIZATION OF GECOL INTERNATIONAL, L.L.C.

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

- 1. Name. The name of this limited liability company is GECOL INTERNATIONAL, L.L.C. (the "Company").
- 2. <u>Duration and Commencement of Existence</u>. The Company shall exist from the date of filing these Articles with the Florida Department of State until dissolved by the Members or until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining Members.
- 3. <u>Purpose</u>. This limited liability company is organized for the purpose of transacting any and all lawful business authorized to limited liability companies under applicable law.
- 4. <u>Mailing Address and Street Address</u>. The mailing address and the street address of the principal office of the Company is:

5. Registered Agent and Office. The name of the initial registered agent of the Company is WLMC Registered Agents, Inc. The street address of the initial registered agent of the Company is:

- 6. <u>Capital</u>. The capital of this limited liability company is \$10,000.00, which shall be paid entirely in cash. Additional capital contributions are not required, but may be made by the Members in accordance with the terms of that certain Operating Agreement executed by the Members: (i) German Emilio Ayubi; and (ii) Andrea Marcela Vargas.
- 7. <u>Additional Members</u>. Additional Members may be admitted to the Company, but only if all of the current Members agree to the admission of the additional Members and to the terms of admission.

- Termination of Membership. If a Member of the Company dies, retires, resigns, is expelled or dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a Member in the Company, the remaining Members may, by unanimous written agreement, continue the business of the Company.
