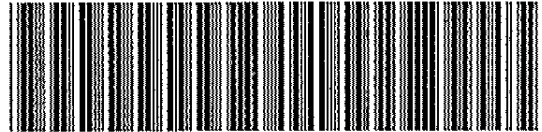


2. Article I of the Articles of Organization of **SEAMAX OF HUNTER'S RIDGE, LLC** hereby is amended to read as follows:
