#### ARTICLES OF ORGANIZATION OF

### CRESCENT STAR CONSULTING, LC, a Florida Limited Liability Company

#### ARTICLE I NAME

The name of this Limited Liability Company (this "Company") shall be CRESCENT STAR CONSULTING, LC, and its principal place of business shall be c/c SMITH MACKINNON PA, Attn: C. Yanki Sokmensuer, Esq. The mailing address shall be 255 S. Orange Avenue, Suite 800 – Citrus Center, Orlando, FL 32801.

### ARTICLE II COMMENCE OF CORPORATE EXISTENCE

This Company shall exist for a period of thirty (30) years, commencing upon the date of filing of these Articles of Organization with the State of Florida, Secretary of State, unless sooner dissolved according to law.

### ARTICLE III GENERAL PURPOSE; GENERAL POWERS
