## ARTICLES OF ORGANIZATION

OF

WVA, LLC

1. Name. The name of this limited liability company is WVA, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is 3401 Westview Drive, Naples, Florida 34104.
