ARTICLES OF ORGANIZATION

IRRI-GATOR LANDSCAPING, LLC.

These Articles of Organization are filed for the purpose of creating a Limited Liability Company pursuant to the Florida Limited Liability Act, Chapter 608 Florida Statutes (the "Act").

ARTICLE I

NAME

The name of the Company is and shall be: **IRRI-GATOR LANDSCAPING, LLC.**

ARTICLE II

TERM

The existence of the Company will commence upon the filing of these Articles of Organization with the Florida Department of State, and its duration shall be perpetual until dissolved as required by the Act or as provided in the Company's Regulations. In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or other event which terminates the continued membership of a member in the Company (a "Terminating Event"), the Company may continue upon the affirmative vote of a majority in interest of the remaining members to do so; provided, such affirmative vote must be made within ninety (90) days following the Terminating Event.
