ARTICLES OF ORGANIZATION OF
AIRPORT NEWSPAPER PUBLISHING GROUP, LLC.

The undersigned member, acting as the organizer of a limited liability company organized under the Florida Limited Liability Company Act (Chapter 608, F.S.) (the "Act"), does hereby adopt the following Articles of Organization for **AIRPORT NEWSPAPER PUBLISHING GROUP, LLC** (the "Company"):

The name of the Company is: **AIRPORT NEWSPAPER PUBLISHING GROUP, LLC.**

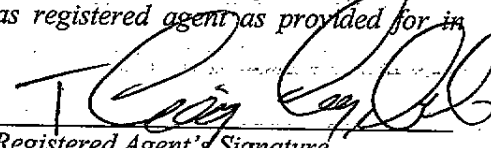
ARTICLE TWO
