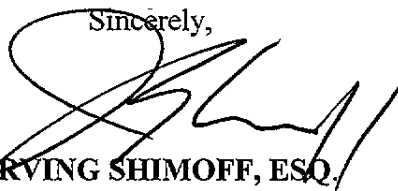

**ARTICLE V - Members Rights to Continue Business**

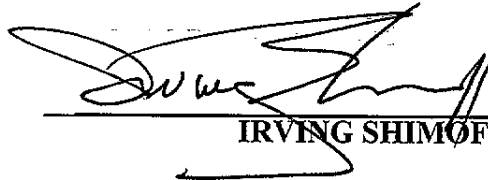
