**ARTICLES OF ORGANIZATION**  
**OF**  
**WOPPMAN TECHNOLOGIES, L.L.C.**

The following shall be the Articles of Organization for Woppman Technologies, L.L.C, a limited liability company organized under the laws of the State of Florida (the "Articles").

**ARTICLE 1 – NAME AND PLACE OF BUSINESS**

The name of the limited liability company shall be Woppman Technologies, L.L.C. (the "Company"), and its place of business shall be 9438 Daughtrey Road, Sidell, Florida, 34266. The Company may establish offices at such other place or places as may be designate by the members.

**ARTICLE 2 – PURPOSES AND POWERS**

The Company is organized and authorized to transact and to engage in any and all activities or businesses that may lawfully be transacted and engaged in by a limited liability company formed under the Florida Statutes. In pursuance of the foregoing, the Company shall have and may exercise all of the powers conferred by the laws of the State of Florida on limited liability companies, and may act in any and all capacities, including (without limitation) principal, agent, partner, nominee and attorney-in-fact, insofar as lawful for limited liability companies under the laws of the State of Florida.

### **ARTICLE 3 – CONTRIBUTIONS TO CAPITAL**

Capital contributions in the amount of \$100 cash shall be paid to the Company by the members. Additional contributions to the capital of the Company, as may be determined from time to time by a majority in interest of the members, may be made as required for purposes of the business of the Company.

### **ARTICLE 4 – PROFITS AND LOSSES**

The members shall share in the profits of the Company in accordance with the provisions of the regulations of the Company. Any losses that occur in the operation of the Company shall be paid out of the capital of the Company and the profits of its business in accordance with the provisions of the regulations of the Company.

### **ARTICLE 5 – MANAGEMENT**

Management of the Company is reserved to its managers, whose names and addresses are as follows upon the date of filing of these Articles with the Department of State of the State of Florida:

liability company powers shall be exercised by or under the authority of, and the business and affairs of the Company shall be managed under the direction of the manager(s) of the Company. This Article 5 may be amended from time to time in the regulations of the Company by a vote of a majority in interest of the members.

## **ARTICLE 6 – DURATION**

The Company shall exist until 29 years from the date of filing of these Articles with the Department of State of the State of Florida, or until dissolved in a manner provided by law, or as provided in the regulations of the Company. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event that terminates the continued membership in the Company of a member, the remaining members shall have the right to continue the business upon the written consent of all of the remaining members.

## **ARTICLE 7 – RESTRICTIONS ON MEMBERSHIP**

Members shall have the right to admit new members by the written consent of a majority in interest of existing members. Contributions required of new members shall be determined as of the time of the admission of the new member of the Company. A member's interest in the Company may not be sold or otherwise transferred, except with the written consent of all members.

## **ARTICLE 8 – REGULATIONS**


The power to adopt, alter, amend or repeal the regulations of the Company shall be vested in the members.

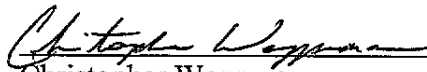
