The name of the limited liability company shall be Lakeworth Professional Plaza, L.L.C.

ARTICLE II - ADDRESS

ARTICLE VII - ADMISSION OF NEW MEMBERS.

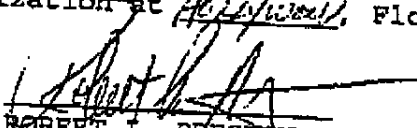
ARTICLE VIII - TERMINATION OF EXISTENCE

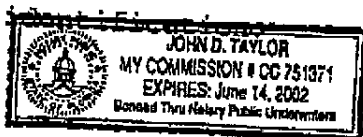
