**ARTICLES OF ORGANIZATION
FOR
DBJ PROPERTIES, LLC
(a Florida Limited Liability Company)**

The undersigned, being a member of DBJ Properties, LLC, a Florida Limited Liability Company, and acting as the organizer of the Limited Liability Company, hereby adopts the following Articles of Organization for the Limited Liability Company pursuant to Chapter 608, Florida Statutes.

ARTICLE I - Name

The Limited Liability Company is to be a Member-managed company.

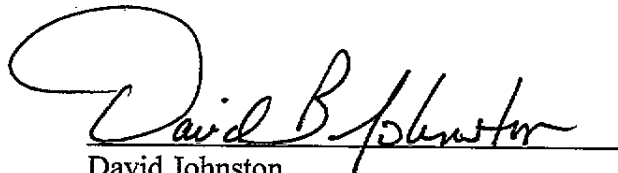
ARTICLE VIII - Effective Date
