**ARTICLES OF ORGANIZATION
OF
UNITED TEACHERS OF DADE CHARTER SCHOOLS, LLC**

**ARTICLE I
Name**

The name of the Limited Liability Company is **UNITED TEACHERS OF DADE CHARTER SCHOOLS, LLC** (the "Company").

**ARTICLE II
Address**

**ARTICLE III
Registered Office; Registered Agent**

**ARTICLE IV
Management**

The Company is to be managed by a manager and is, therefore, a manager-managed company. The name of the Manager is **KSIXTEEN, LLC**, a Delaware limited liability company.

**ARTICLE V
Dissolution**

Upon the dissolution or winding up of this Company, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Company, shall be distributed to the sole member of the Company, **UNITED TEACHERS OF DADE CHARTER SCHOOLS, INC.**, a Florida not for profit corporation (the "Member"), organized and operated exclusively for educational purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws. If at the time of the dissolution of this Company, the Member does not qualify for tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding section of any future federal tax code, the remaining assets of the Company shall be distributed to another corporation which qualifies for tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding section of any future federal tax code.
