Second: The following Amendment to the articles of organization of R&D Carbon Technology International LLC should be executed as follows:

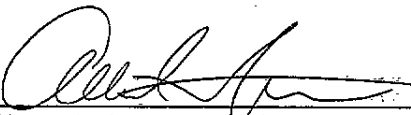
The name of the Company shall be Technology International LLC

The name of the limited liability company is Technology International LLC (hereinafter the "Company").

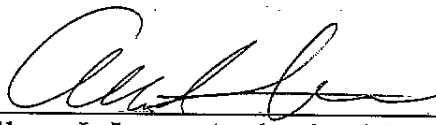
