## **ARTICLES OF ORGANIZATION**

### **FOR**

### **WEYAND EAST FOOD SERVICE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### **ARTICLE I -- NAME**

The name of the limited liability company shall be Weyand East Food Service, LLC ("Company").

#### **ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the Company shall be 2801 East Hillsborough Avenue, Tampa, Florida 33610.

#### **ARTICLE III -- DURATION**

The Company shall commence its existence as of June 22, 2001, a date that is less than five (5) days prior to the filing of these Articles as permitted by Florida Statutes Section 608.409. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these articles of organization.

The purpose for which the Company is organized is to engage in any and all business and activities permitted by the laws of the State of Florida.

#### **ARTICLE VI -- ADMISSION OF NEW MEMBERS**

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members.


## ARTICLE VII -- TERMINATION OF EXISTENCE


