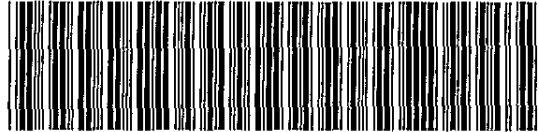

ARTICLE OF AMENDMENT TO
ARTICLES OF ORGANIZATION FOR
SCHOOL DEVELOPMENT LLC
A FLORIDA LIMITED LIABILITY COMPANY

THIS IS TO CERTIFY THAT:

FIRST: This Article amends the Articles of Organization of SCHOOL DEVELOPMENT LLC, a Florida limited liability company ("Company").

SECOND: The Articles of Organization were filed with the Florida Department of State on June 26, 2001.

THIRD: The Articles of Organization were previously silent as to the "Purpose" of the Company. The Articles of Organization, as amended, shall provide as follows:

"Purpose. The Company is organized solely to purchase, acquire, buy, sell, own, trade in, hold, develop, manage, subdivide, finance, refinance, mortgage, operate, improve, maintain, repair, alter or modify that certain property located at 11100 NW 27th Street, Miami, FL 33172-5001, or any additional lands for the purpose of leasing said lands to a charter school and for use as a charter school facility. The Company shall engage in any other lawful activities which are reasonably necessary convenient or incidental to the foregoing purposes, and may make and manage passive investments of its available funds from time to time."

FOURTH: The Articles of Organization previously provided for management by managing members of the Company. Article IV-MANAGEMENT shall now provide as follows:


ARTICLE IV - MANAGEMENT

SIXTH: Except as expressly modified by this Article, the Articles of Organization remains unchanged and in full force and effect.
