ARTICLE OF AMENDMENT TO ARTICLES OF ORGANIZATION FOR SCHOOL DEVELOPMENT LLC A FLORIDA LIMITED LIABILITY COMPANY

THIS IS TO CERTIFY THAT:

FIRST: This Article amends the Articles of Organization of SCHOOL DEVELOPMENT LLC, a Florida limited liability company ("Company").

SECOND: The Articles of Organization were filed with the Florida Department of State on June 26, 2001.

SIXTH: Except as expressly modified by this Article, the Articles of Organization remains unchanged and in full force and effect.
