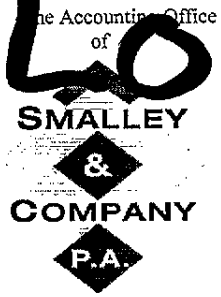

OF

**ARTICLE I
NAME**

CONTINUATION OF COMPANY


