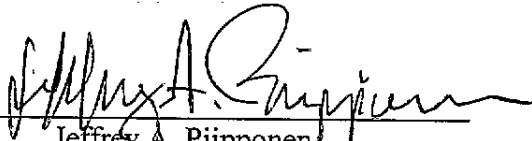

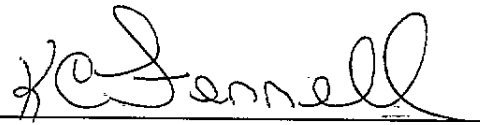
ARTICLE X. - LIMITATION ON AGENCY AUTHORITY OF MEMBERS
