ARTICLES OF ORGANIZATION REPUBLIC ENTERPRISES, LLC A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE 1: NAME

The name of the Limited Liability Company ("LC") shall be Republic Enterprises, LLC.

ARTICLE 2: PURPOSE

The LC may engage in any lawful business not prohibited by statute or law.
