

**ARTICLES OF ORGANIZATION
FOR
OPEN MRI OF LOUISIANA, LLC
(a Florida Limited Liability Company)**

The undersigned, being a member of Open MRI of Louisiana, LLC, a Florida Limited Liability Company, and acting as the organizer of the Limited Liability Company, hereby adopts the following Articles of Organization for the Limited Liability Company pursuant to Chapter 608, Florida Statutes.

ARTICLE I - Name

ARTICLE VI - Members Rights to Continue Business



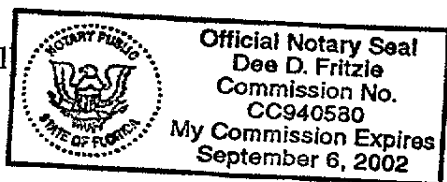


