ARTICLE 1

Name and Duration

The name of this Limited Liability Company is GLOBAL MEDIA ALLIANCE, LLC (hereinafter referred to as the "Company"). The duration of the Company shall be perpetual.

ARTICLE II

Principal Office

The address of the principal office of the Company is 1220 Woodmere, Winter Park, Florida 32789, or such other place as the Member(s) may determine from time to time. The mailing address shall be the same as the principal office address.

ARTICLE III

Registered Office and Agent
