**ARTICLES OF ORGANIZATION
FOR

ARTICLE VII - Management

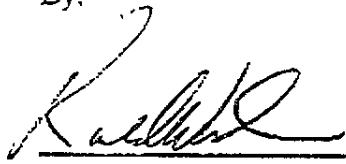

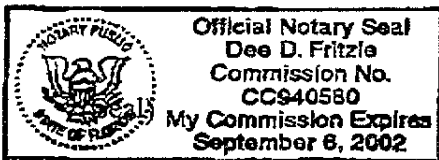
