FIRST AMENDMENT TO
ARTICLES OF ORGANIZATION
OF
CHRISTIAN ELECTRICIAN, LLC

The undersigned, for the purpose of amending the Articles of Organization of Christian Electrician, LLC, pursuant to the Florida Limited Liability Company Act, F.S. Chapter 608, certifies as follows:

1. The name of this limited liability company is CHRISTIAN ELECTRICIAN, LLC (the "Company").
2. The Company was formed by Articles of Organization which were filed with the Florida Secretary of State on July 3, 2001.
3. The Articles of Organization of the Company are amended to delete the originally filed version of Article VII ("Management") and to substitute the following Article VII:

**ARTICLE VII
MANAGEMENT**

The Company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization. Initially, the Company shall have one member. The name and address of the sole member of the Company is as follows:



5. All provisions of the Company's originally filed Articles of Organization, other than Article VII, remain unchanged by this First Amendment.
