## ARTICLES OF ORGANIZATION

OF

### BEAR IMAGE LLC

1. Name. The name of this limited liability company is BEAR IMAGE LLC, (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.


6. Management of the Company. The management of the Company is reserved to its members. The Company shall be managed in accordance with the Operating Agreement adopted by all of the members.
