ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

SOUTHWEST FLORIDA WOMEN'S GROUP BUILDING COMPANY, L.L.C.

The undersigned, for the purpose of amending the Articles of Organization of SOUTHWEST FLORIDA WOMEN'S GROUP BUILDING COMPANY, L.L.C., a Florida limited liability company, hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.

FIRST: The Articles of Organization of SOUTHWEST FLORIDA WOMEN'S GROUP BUILDING COMPANY, L.L.C., were filed with the Florida Department of State on July 5, 2001, and were assigned Document Number L01000010817

SECOND: The following amendment to the Articles of Organization was adopted by Southwest Florida Women's Group Building Company, L.L.C.: Article VIII is hereby deleted in its entirety and replaced as follows:

The Company shall be managed by a Manager(s) in accordance with the Operating Agreement adopted by the Members for the management of the business and affairs of the Company. A member of the Company may serve as a Manager. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization.
