## ARTICLES OF ORGANIZATION

OF

### SURESPEED PRODUCE TRANSPORT & LOGISTICS, LLC

1. Name. The name of this limited liability company is SureSpeed Produce Transport & Logistics, LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
4. Place of Business. The mailing and street address of the Company's principal office is 199 Silverado Dr., Naples, Florida 34119.
5. Registered Agent and Office. The name of the initial registered agent of the Company is Matthew L. Grabinski, Esq. The street address of the initial registered agent of the Company is 5551 Ridgewood Drive, Suite #101, Naples, Florida 34108.
6. Management of the Company. The Company shall be a member-managed Company, in accordance with the Operating Agreement adopted by the members. The name and address of the initial Managing Member, who shall serve until the first annual meeting of the members or until his successor is elected and qualified, is Joseph J. Toohey.
7. Voting. The Company is authorized to issue membership units with voting rights and membership units without voting rights.
8. Certificated Interests. The members' interests in the Company may be evidenced by certificates, at the discretion of the Managing Member.
9. Additional Members. The company shall have the right to admit additional members pursuant to the terms and conditions of the Operating Agreement to be adopted by the members.


