**ARTICLES OF ORGANIZATION  
FOR ATLANTIC EASTERN, LLC**

**ARTICLE 1 – Name.** The name of the limited liability company shall be Atlantic Eastern, LLC.

**ARTICLE 2 – Address of Principal Office.** The mailing address and principal office of the limited liability company shall be 7041 Grand National Drive, Suite 215, Orlando, Florida 32819.

**ARTICLE 3 – Registered Office and Registered Agent.** The name and the Florida street address of the initial registered agent is: Philip K. Calandrino, Esquire, Philip K. Calandrino, P.A., 7232 Sand Lake Road, Suite 201, Orlando, Florida 32819.


**ARTICLE 4 – Management.** One or more managers shall manage the limited liability company. Therefore, it is a manager-managed company. Initially, Arif Rajan shall serve as the initial manager of the limited liability company. The initial manager shall serve in such capacity until his resignation or his removal by a majority vote of the members.

**ARTICLE 5 – Membership.** The limited liability company shall have the following two initial equity owners, who shall hold an ownership interest in the limited liability company as indicated: (1) Arif Rajan 1% and (2) Gulzar Rajan 99%.


