ARTICLES OF ORGANIZATION FOR CPS DESTIN LLC

The undersigned person forms a Florida limited liability company pursuant to the Florida Limited Liability Company Act (the "Act"), as follows:

1. The name of the limited liability company (the "Company") shall be CPS Destin LLC.
2. The term of the Company is perpetual, except as provided in the Company's regulations.
3. The mailing address and the street address of the principal office of the Company is 3401 West End Avenue, Suite 600, Nashville, Tennessee.
4. The name and street address of the initial registered agent is Sharon Dinwiddie, 586 Grand Boulevard, Suite 100, Destin, Florida 32550.
5. The Company shall admit additional members upon unanimous agreement of the members with respect to the terms and conditions of such admissions.
6. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company (collectively, a "Disassociated Member"), the remaining members may elect, by unanimous decision, to continue the Company's business, so long as the Company redeems the Disassociated Member's membership interest on terms set forth in the Company's regulations.
