ARTICLES OF ORGANIZATION

OF

URBAN DEVELOPMENT GROUP, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

Name

The name of the Limited Liability Company shall be Urban Development Group, L.L.C. (the "Company").

Registered Office and Agent


